Procedures for Exhibitors

Request for Certificate of General Liability Coverage

In accordance with the FSPHP's General Liability Coverage Policy, it is now required that exhibitors submit a certificate of Commercial General Liability Coverage, naming Federation of State Physician Health Programs as an Additional Insured on your organization's policy, written with a single limit of \$1,000,000 per each occurrence and an aggregate limit of at least \$2,000,000. This is something that your insurance provider can typically provide to you.

Your Certificate of Insurance in naming FSPHP as an Additional Insured should read:
