

VISIBILITY

Meal Functions in the Exhibit Hall: To encourage participants to visit exhibitors, all meal functions (silent auction dinner, breakfast, breaks, and lunches) will be in the Exhibit Hall. Our poster session dessert and coffee will be provided in the Foyer.
