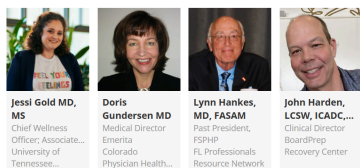
The countdown is on for the FSPHP 2025 Conference & Annual Membership Meeting!

This event is what the FSPHP community is all about! You do not want to miss it.

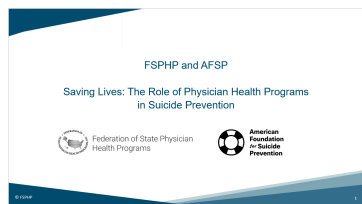

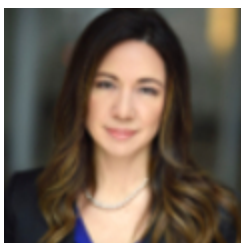

Join Us In-Person for the Annual Member Business Meeting; April 26 in Seattle Attention FSPHP State-Voting, Associate, International, and Honorary Members

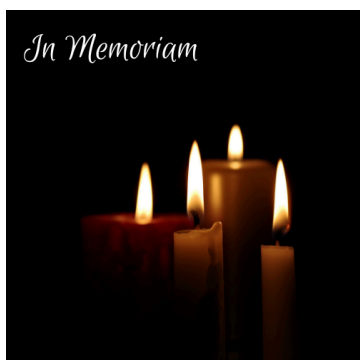
