- No state may hold more than one regional directorship.

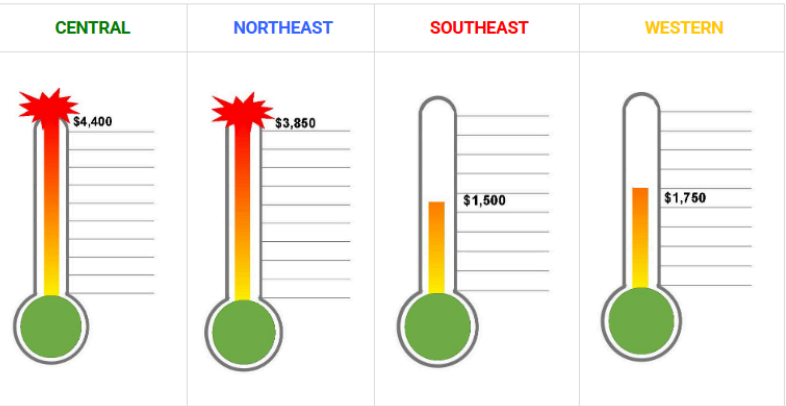
