AB 408 Update - California Physician Health and Wellness Program

AB 408 passed out of the Senate Committee on Business, Professions and Economic Development on Monday, July 7th, with only one nay vote. The full hearing can be viewed here (AB 408 is at the 1 hr; 32 sec. mark):

As of yesterday, July 10, 2025, the author of the bill has decided to continue discussion with the legislature and shift the bill to a two-year bill, with more activity likely in the fall.

As a reminder, FSPHP submitted a <u>letter to the Committee in support of the PHP model</u>. Dr. Edwin Kim, FSPHP President-Elect, attended the hearing to provide FSPHP's support for a PHP model in California.

Meanwhile, opposition efforts continue from consumer advocate groups, who claim the legislation supports a "secret drug and alcohol diversion program" that could compromise patient safety.

Tennessee Sets the Standard in Conditional Admission Reform

The Tennessee Bar Association has published a column by FSPHP member Joseph (Buddy) Stockwell III, JD, titled Leading the Way: New ABA Model Rule on Conditional Admission to the Practice of Law Confirms Best Practices by TLAP, in the July/August 2025 issue of the Tennessee Bar Journal, spotlighting Tennessee's leadership in conditional admission reform.

The column covers the new ABA Model Rule on Conditional Admission, praising TLAP as a nationally recognized, ADA-compliant "gold standard" program aligned with ASAM's Standards for Safety-Sensitive Workers.

It highlights **Justice Janice Holder's** pioneering work to focus solely on conduct—not diagnosis—in bar admissions, a model now reflected in the ABA's approach. **Judge Butch Childers**, a member of the ABA Law School Committee, helped champion this reform.

Notably, **FSPHP President Dr. Michael Baron**—appointed by the Tennessee Supreme Court—has served on the TLAP Commission for the past four years, playing a key role in advancing TLAP's nationally recognized best practices.
