
Research Spotlight: Drs. Lisa Merlo Greene & Cristiana Araujo Publish Findings on Suicide Risk Screening in Physician Health Programs

Dr. Lisa Merlo Greene, Co-Chair of the FSPHP Research Committee, Professor of Psychiatry at the University of Florida, and Director of Research at Professionals Resource Network, Inc., and **Dr. Cristiana Araujo**, FSPHP Research Committee Member, publish findings on their study titled *Implementation of Structured Suicide Risk Screening in a State Physician Health Monitoring Program* in the *Archives of Suicide Research* addresses a critical public health concern: physician suicide.

Physicians face elevated risks of suicide due to burnout, psychological distress, and substance use disorders. This research explores how Physician Health Programs (PHPs) can play a pivotal role in suicide prevention. This study offers a promising roadmap for other state PHPs to adopt structured suicide risk screening protocols. By integrating mental health monitoring into PHPs, we can better protect both physician well-being and patient safety.
